DATE: December 9, 2022

State Chairman, Steve Pearce, set the following dates for the 2023 Biennial County Conventions. All conventions and caucuses shall be held in accordance with the Uniform State Rules (USR) and Supplementary County Rules (SCR).

December 16-30, 2023 Separate Ward/Precinct Caucuses

January 6-15, 2023 Biennial County Conventions – or – County Mass

Meeting including Ward/Precinct Caucuses

County Officers will determine the date, time, and place, and issue the call for the ward/precinct caucuses and county conventions. County officers should make every effort to include representation from all wards/precincts of the county.

The USR (Uniform State Rules), in accordance with the SCR (Supplementary County Rules), permit the county officers to determine whether to hold ward/precinct caucuses at a time and place separate from the county convention, or to hold a centrally located County Mass Meeting (technically, a Mass Meeting is **not** a single meeting. Each Ward/precinct caucuses at the same location).

NOTE:

Counties that hold separate ward/precinct caucuses can adjust the timing of the County Central Committee notification and published notice accordingly (14 days prior to the County Central Committee meeting and 14 days prior to meeting for published notice).

Within 72 hours after the county officers meet:

Ward/Precinct Caucuses Prior to the County Convention

Separate ward/precinct caucuses should be held between December 16, 2022 - December 30, 2022

<u>USR 4-2-1.</u> A.

<u>Biennial Caucuses to Elect Officers and Delegates:</u> In odd-numbered years during the dates specified by the state chairman, the elected officers of each county central committee shall call caucuses for each ward in a ward-based county or for each precinct in a precinct-based county for the purposes of electing new officers and for electing delegates to the Biennial Organizational County Convention.

The Ward/Precinct Caucuses are held to allow grass roots participation in the process. For this reason, there are no proxies allowed at the Ward/Precinct Caucuses. Also, there are no automatic berths to the County Convention by virtue of holding an office. Anyone who wants to be a delegate must run as a delegate.

USR 4-2-1.E.

<u>Ward/Precinct Caucuses – Order of Business:</u> The elected officers of each County Central Committee shall prescribe such rules for the Conduct of Ward/Precinct Caucuses as they may deem proper, in addition to the following minimum Order of Business for a Ward/Precinct Caucus:

- 1. Call to order by the Ward/Precinct Chairman;
- 2. Reading of the Official Call [as issued by the county elected officers];
- 3. Nomination and Election of Officers of the Ward/Precinct Caucus;
- 4. Nomination and election of new ward/precinct officers, when required by the caucus call, conducted by the caucus officers;
- 5. Nomination and election of delegates to a county convention, when required by the caucus call, conducted by the caucus officers
- 6. Any other proper business.

USR 4-3-1.F.

<u>Ward/Precinct Caucuses – Proxies:</u> No proxies shall be recognized or exercised at any Ward/Precinct Caucus.

USR 4-3-1.G.

Ward/Precinct Caucuses – Adjournment to Another Time, Date, and/or Public Place: A Ward/Precinct Caucus shall be held at the time, date, and public place designated in the Official County Caucus Call, and shall not be adjourned to another time, date and/or public place.

NOTE:

- 1. Have a current Registered Voter List available for use by the Credentials Committee and Officers.
- 2. Retain all voting materials, ballots, sign-in sheets, etc. and deliver to County Chairman.

COUNTY CONVENTIONS

IF County Supplemental Rules require separate Ward/Precinct Caucuses:

- 1. Officers meet and set dates and public places for Ward/Precinct meeting and date and public place for County Convention.
- 2. Secretary promptly provides written notice to County Central Committee Members.
- 3. Officers arrange for **published notice** no less than 14 days prior to Ward/Precinct Caucuses (dates of both Ward/Precinct Caucuses will be included in this public notice).

IF County Supplemental Rules provide for mass meetings:

- 1. Officers meet to set date and public place for mass meeting or separate meeting.
- 2. Secretary promptly provides written notice to County Central Committee Members.
- 3. Officers arrange for **published notice** no less than 14 days prior to the first meeting date (dates of both the Ward/Precinct Caucuses and the County Convention shall be included in this public notice).

IF County Supplemental Rules are silent on Ward or Precinct Meetings:

- 1. Officers meet to choose either a mass meeting or separate meeting.
- 2. Secretary promptly provides written notice to County Central Committee Members
- 3. Officers arrange for **published notice** no less than 14 days prior to the first meeting date (dates of both the Ward/Precinct Caucuses and the County Convention shall be included in this public notice).

Essential Tasks for County Conventions

- 1. Mail or email notice to the County Central Committee Members (see Sample Call).
- 2. Publish notice in a newspaper of general circulation, stating the time, date, and public place (We have provided sample ads in this packet).

Essential Tasks for Ward/Precinct Caucuses

- 1. Have a current Registered Voter List available for use by Credentials Committee as Officers.
- 2. Retain all voting materials, ballots, sign-in sheets, etc. and deliver to County Chairman.

Please be aware you need to have a credentials committee and voter tabulation committee, and other committees as your county supplemental rules may require.

In addition, the <u>Uniform State Rules</u> include instruction on <u>how to properly conduct Biennial</u> <u>County Conventions for counties, wards, and precincts.</u>

The State Party will publish a general notice in the newspaper per Chapter 1 NMSA 1978 1-7-3.

This notice is not a substitute for the county party's responsibility to publish a notice in its local paper.

OFFICIAL PROXY FORMS

Any properly elected CCC member may appoint any qualified registered Republican voter of his or her county as his or her proxy to act and vote in his or her stead at Biennial County Convention.

Each Official Proxy must be signed by the CCC Member giving the proxy and will name the person to be the proxy, will name the convention for which given, and will state the date it was signed.

No person will be permitted to hold and/or exercise more than five (5) proxies for the Biennial County Convention.

A COPY OF THE COUNTY PUBLISHED NOTICE MUST BE SENT TO THE STATE PARTY AS SOON AS IT HAS BEEN PUBLISHED.

Proper Call of County Conventions

The table below outlines the different processes that qualify as proper call for county conventions. Firstly, county officers must determine which of the three processes is in accordance with their respective county supplemental rules. Once you determine which procedure best suits your county, you **must** follow the steps outlined below.

Officers meet and set dates & public places for Ward/ Precinct meetings and date & public place for County Convention



Secretary promptly provides written notice to County Central Committee members



Officers arrange for **published notice** no less than 14 days prior to Ward/Precinct Caucuses (Dates of both the Ward/Precinct Caucuses and the County Convention will be included in this public notice.)

IF Country Rules provide for Mass Meetings:




